Lighting design and manufacturing company **arturo alvarez** is proud to announce our **1st arturo alvarez Young Talent Award.**

After nearly twenty-five years in the business, our aim is to highlight our commitment to supporting the new generation of creators, allowing your designs to be presented, together with your name, throughout the world with our brand's values and philosophy.

OBJECTIVE

The challenge consists of designing a decorative interior lamp.

PRIZE

The sole winner will receive a prize consisting of:

- » 2500 €
- » The possibility of seeing your design produced and forming a part of our new catalogue. Your name as the creator of the design will be included in all of the company's publications (including its catalogue, website, and leaflets), respecting the intellectual authorship of the design at all times.
- » A trip to Milan with Arturo Álvarez to present the company's new designs at the "Fiera del Mobile EuroLuce" in the spring of 2019. This includes a return air ticket, two nights' hotel accommodation, and a pass for the event.

PARTICIPANTS

Any person over the age of 18 and below the age of 30 may take part.

Entries may be sent from any part of the world, regardless of your country of origin or nationality. We will be delighted to receive your designs, from wherever you are.

Once you send the form, your details will be included in a database of participants, which we will use to keep you up to date with the latest news about the competition.

BRIEFING

All entries must meet the following requirements in order to be accepted:

- » All of the manufacturing processes involved in the decorative part of the lamp must be designed **to be created by hand**.



- » The size of the lampshade must not exceed the following measurements: 50 cm wide x 50 cm high x 50 cm deep.
- » The lamp must be designed to operate with a conventional power source (E-27 / E-26), and LED equipment.
- » Special consideration will be given to designs using materials that are as environment-friendly as possible.

DEADLINES AND DATES

Deadline for the presentation of entries:
from 21 November 2017 to 23 March 2018.

Publication of finalists on our website and social media:
17 April 2018

Publication of winner on our website and social media:
24 April 2018.

PRESENTATION OF ENTRIES

Entries must be presented in digital format on a CD or DVD.

The CD or DVD must be presented in a box or case, clearly indicating your name and the name of the design being entered. This information must also be written on the CD or DVD.

The CD or DVD must contain three folders:

- » **Personal documentation**
- » **Technical details**
- » **Images**

The **Personal Documentation** folder must include:

- » The fully completed entry form. This is a PDF that we will send you when you had filled the registration form that you will find in our website.
- » Personal ID: a copy of your ID card or passport, or equivalent documentation if you are not resident in Spain.





The **Technical Details** folder must include:

- » Details of the project in PDF format in A3 landscape format, totalling a maximum of 15 pages. The document must contain at least the following:
 - Presentation of the design.
 - Sketches and properly dimensioned diagrams of the product.
 - A description of the different manufacturing stages, indicating that the creation process for the decorative part of the lamp is intended to be made by hand.
 - 3-D images.
 - A photomontage showing the lamp in a setting.
 - The last page must contain a signed declaration by the entrant, indicating the following:
 - That the design does not infringe the intellectual and/or industrial property of any third parties
 - That the proposed design has not been entered in other competitions, or previously published or sold.
- » Illustrations in .dwg and .pdf format.

The **Images folder** must contain:

- » 3-D images in .jpg format. Size: 3000 x 2500 pixels, with a resolution of 300dpi.
- » A photomontage showing the lamp in a setting. Size: 3000 x 2500 pixels, with a resolution of 300dpi.

Special consideration will be given to the presentation of 3-D animations. If presented, these must be included in the Images folder. Special consideration will also be given to the presentation of physical models.

All of the material must be sent before the indicated deadline to the following address:

JURY AND DECISION

The jury will be comprised of experienced professionals from the design, production, marketing, and communication departments of our company, with Arturo Álvarez acting as the chairman.

The jury will meet once the deadline for presenting entries has expired, and will select the 5 finalists from amongst all of the participants. The names of the finalists will be published on our website and social networks on the 17 of April.

The final decision of the jury will be published on the 24 of April, also on our website and social networks. Watch this space!

We will contact the winner on the same day by telephone or e-mail. If we are unable to contact the winner in five working days, the prize will instead be awarded to the person with the next highest score.



OTHER LEGAL MATTERS

The company organising the competition, Calor Color S.L. [hereinafter “**arturo alvarez**”] reserves the right to cut short, extend, modify, or cancel this competition if considered appropriate, or in the event of any special situation that prevents it from being held.

arturo alvarez reserves the right to declare the prize as null and void.

The company **arturo alvarez** reserves the right to produce the winning design or not.

In the event of the company **arturo alvarez** deciding to market the winning design, it reserves the right to make minor modifications to the design that may occur as a result of analysing the manufacturing process. These modifications shall be made, as far as possible, with the consent of the winner of the competition.

The participant gives their express consent and transfers the exploitation rights to the company **arturo alvarez** for an unlimited period. After receiving the prize, the prizewinner waives any future royalty payments, considering the prize as their remuneration.

The company **arturo alvarez** will recognise the moral authorship rights of the winner at all times.

The participants will be held liable for any claims presented by third parties with regard to the authorship of the design presented to the competition. The participants guarantee that they will not present materials or design that infringe the intellectual or industrial property rights of third parties in any way, and as a result agree to hold **arturo alvarez** harmless against any liability arising as a result of any breach or infraction of any third party rights by the participants.

Under no circumstances may the non-monetary part of the prize be exchanged for any other prize, or exchanged for its equivalent value in cash. The company **arturo alvarez** will not accept any liability for any damage or loss arising as a result of the winner enjoying their prize.

The company **arturo alvarez** shall be entitled to publish any of the works received, providing these are in reference to the competition.

The participants in the competition transfer to **arturo alvarez** all rights to exploit the images presented, including the rights for the use, publication, distribution, exhibition, public communication, dissemination, and reproduction via the Internet or any other audio visual means, display or exhibition, of the designs presented to the competition.

The personal details provided by participants will be included on a computerised file which is the property of calor color, s.l. All other matters not specifically addressed in these terms and conditions relating to the competition shall be subject to currently applicable Spanish legislation. Any legal actions arising in relation to the same shall be subject to the decisions of the Courts and Tribunals of the city of Santiago de Compostela, without prejudice to any jurisdiction that may correspond to the parties subject to applicable legislation.
